Terms and Conditions

Compliance with Laws: Customer understands and acknowledges they are responsible and bound to conduct purchase and sale of all products purchased from Tactical Gear Distributors (a U.S. Company) in compliance with all United States Federal laws regarding the purchase, record keeping, storage, temporary, and final disposition of all products purchased from Tactical Gear Distributors.

Customer understands and acknowledges that they are responsible for securing permits/license to fully comply with all U.S. State Department (ITAR) and Commerce Department (BIS) regulations, and to comply with the Foreign Corrupt Practices Act.

Customer understands and acknowledges that they are not acting as an agent of Tactical Gear Distributors. Customer understands and acknowledges that these terms and conditions do not imply any exclusivity for the distribution of products supplied to customer by Tactical Gear Distributors.

Pricing: Prices are subject to change without notice.

Freight: All shipments are shipped FOB, TGD warehouse. \$500.00 free freight program includes shipments to freight forwarders within the continental US states only. Extra heavy or bulky items are excluded. Special delivery charges levied by the freight companies are charged based on their fee schedule. All damaged/missing freight must be reported within 2 business days of delivery of product to the freight forwarder and before it is exported.

Payment: Beginning payment terms for international customers is PREPAY where all orders must be paid in full before the shipment leaves our facility. Acceptable forms of prepayment include the following credit cards: VISA, MASTER CARD, DISCOVER, & AMERICAN EXPRESS. Payment via bank wire is also accepted. Open payment terms are granted through satisfactory review of a signed credit application providing references given by customer are with U.S companies. For open terms customers, invoice balances not paid within 7 days of the due date shall incur a late fee at 2% of the total invoice balance. Thereafter, past due balances shall bear interest charges at a rate of 1.5% per month.

Security Interest: Customer grants to TGD a purchase money security interest in any products sold to customer on credit, and a first security lien right in all products purchased from TGD to secure the payment of all amounts owed TGD. Customer hereby authorizes TGD to sign any document required to perfect TGD's security interest, including financing statements under the Uniform Commercial Code.

Collection: Customer understands and agrees that if open credit is extended, all invoices are to be paid by the due date on the invoice. The customer shall be liable for all cost incurred by TGD in the collection of any delinquent account, including attorney fees and interest charges.

Warranties: Customer understands and acknowledges that TGD makes no representation or warranties of any kind concerning the products it sells, or it's safe or consequential use. Customer agrees to waive any and all implied warranties including merchantability or fitness for a particular purpose.

Notification: Customer agrees to promptly notify TGD of any changes in the ownership or control of its business or in the form of its business entity.
